

저작권 종류



저작권 관련 용어 해설

- 저작자(author)
 - 저작물을 창작한 자
 - 저작인격권과 저작재산권의 원시적 귀속
- 저작재산권자(copyright owner)
 - 저작자로부터 저작재산권의 전부 또는 일부를 이전받은 자
- 저작물이용권자(licensee)
 - 저작재산권자(licensor)로부터 저작물이용을 위한 허락을 받은 자
- 저작물사용자(user)
 - 저작재산권에 속하는 행위를 하는 자 , 읽기 · 보기 · 듣기 등의 방식으로 저작물을 사용하는 자





Open access journals are scholarly journals that are available online to the reader "without financial, legal, or technical barriers...(Wikipedia)

Creative Commons Licenses (CCL)












Open Access 표기 (저자용)

Open Access 정책 템플릿(CC BY)

- OA articles in [journal] are published under Creative Commons licenses.
 These provide an industry-standard framework to support easy re-use of OA material. Under Creative Commons licenses, authors retain copyright of their articles.
- [journal] articles are published OA under a <u>CC BY license</u> (Creative Commons Attribution 4.0 International license). This license allows readers to copy and redistribute the material in any medium or format, and to alter, transform, or build upon the material, including for commercial use, providing the original author is credited.
- In instances where authors are not allowed to retain copyright to their own article (where the author is a US Government employee, for example), authors should contact the Editorial Office (e-mail address) before submitting their article so we can advise as to whether their non-standard copyright request can be accommodated.

Open Access 정책 템플릿(CC BY-NC)

- This is an open-access journal distributed under the terms of the Creative Commons Attribution Non-commercial license, which permits unrestricted use, distribution, and reproduction in any medium, provided the original work is properly cited for non-commercial purpose (http://creativecommons.org/licenses/by-nc/4.0/).
- All published papers become the permanent property of [publisher].
 Copyrights of all published materials are owned by [publisher]. Permission must be obtained from [publisher] for any commercial use of materials. Every author should sign the copyright transfer agreement forms (https://www.escienceediting.org/authors/copyright_transfer_agreement.php).

Open Access 정책 템플릿(APC)

- In order to publish in [journal], authors of accepted articles are required to pay an article processing charge (APC). The APC is determined at the date of acceptance.
- The APC for all published Articles is as follows, subject to VAT or local taxes where applicable:

 We offer APC waivers and discounts for papers published in our fully open access journals whose corresponding authors are based in the world's lowest income countries (see <u>our APC waivers and discounts policy</u> for further information). Requests from other authors for APC waivers and discounts will be considered on a case-by-case basis, and may be granted in cases of financial need.

All applications for APC waivers and discounts should be made as part of the submission process; requests made during the review process or after acceptance will not be considered.

Open Access 정책 템플릿(No APC)

 No page charge or article processing charge applies. There is also no submission fee. It is the platinum open access journal that means there is no author-side fee.

Open Access 정책 템플릿(Author self-archiving)

 This policy sets out the ways in which [journal] authors can self-archive versions of their work on their own webpages, on institutional webpages, and in other repositories. Please be aware that policies and embargo periods may differ from journal to journal, so ensure that you have selected the correct journal policy (*Accepted Manuscript embargo period)

아카이빙의 개념

- 아카이브란?
 - 공적 기록이나 역사적 자료가 보존되는 장소 (A place in which public records or historical materials are preserved.)
 - 정보의 리포지터리 또는 컬렉션

Archiving

- 종이 아카이브
 - 아카이브 기관 : 국가 도서관
 - 주요 고려 사항 : 서가 목록 관리, 물리적 공간 확보, 온도/습도 관리
- 디지털 아카이브
 - 아카이브 기관 : 출판사, 데이터 센터
 - 주요 고려 사항: 메타데이터 관리, 디지털 저장 공간 확보, 보안/안정성 관리
 - Dark Archive vs. Public Archive


학술지 아카이빙 정책 필요성

- 아카이빙 정책의 필요성:
 - 학술지에 개재된 논문은 검증된(공적) 과학적 기록이므로
 - 학술지 발간이 중단되었을 때, 어디서 어떻게 과거 발간 논문을 찾아 볼수 있을 지 방법을 제시할 필요가 있음.
 - 아카이브를 의무화한 자금으로 연구한 저자의 요청(예, PMC)
 - DOAJ 등재 신청 양식: Best Practice 질문에 Archiving Policy 작성 항목 포함
 - COPE와 Plan S의 출판 가이드 : 최소 하나 이상의 장기 아카이브에 논 문을 저장할 것을 권고
- Archiving policy refers to:
 - The plan for where to deposit existing publications when a journal stops being published so that its articles can be retrieved again at any time.



CSRC Publishing

DIGITAL ARCHIVING AND PRESERVATION

In order to digitally preserve all published scholarly content including that of JAFEE, CSRC Publishing submits the journals' content to Portico for digital archiving for long term digital preservation. This information can be found on: https://www.portico.org/publishers/csrc/. Furthermore CSRC Publishing commits to submit the metadata of JAFEE and all other journals to LOCKSS and CLOCKSS via PKP PN and other institutional repositories such as Repec. This is to make sure that the published scholarly content by CSRC Publishing remains available to the community despite discontinuation of any journal or any accidental loss of journals data in its personal archival records. CSRC Publishing has further made sure that the metadata of all its open access journals is compliant to well known repository services and their digital crawlers may regularly collect it for record and preservation.
